### DAY 1 SUNDAY, APRIL 27

### ORANGE BEACH

(Dinner)

### ORANGE BEACH

(Breakfast, Lunch, Dinner)

After breakfast at the hotel, we will depart for the beautiful **Bellingrath Gardens and Home**. This impressive sixty-five-acre complex is listed on the National Register of Historic Places, and we'll have the opportunity to stroll through the gardens filled with thousands of colorful blooms. There's always something blooming at Bellingrath, but Spring means the sweet aroma of angelonia, begonias, cape daisies, easter lilies, marguerite daisies, pentas, petunias, roses, and more will fill the air! Walter and Bessie Bellingrath's home was the most modern 1935, and a tour of the house will introduce us to its beautiful design and the couple's original furnishings. We will enjoy lunch as a group before exploring the birthplace of Mardi Gras at the **Carnival Museum**. Our guided tour will show us how the Mardi Gras Festival was first celebrated in Mobile, tracing back to the early 18th century. Discover how French settlers introduced Mardi Gras to Mobile and how it has transformed into the vibrant and colorful celebration we know today. This evening, we are in for a treat as we embark on an exhilarating **Murder Mystery Cruise**. Cruise, dine, and solve the crime aboard the Perdido Queen Paddlewheel Riverboat!

### DAY 3 TUESDAY, APRIL 29

### ORANGE BEACH

(Breakfast)

Following breakfast, we are off to **Alligator Alley** to observe alligators in their natural habitat across twenty acres of wetlands and learn about their role in the local ecosystem, along with encountering turtles, ospreys, owls, bullfrogs, and more. Next, we'll visit **B&B Pecan Co.** to discover the pecan harvesting process and explore the charming farm grounds. After returning to the hotel, you'll have the remainder of the day to relax and explore. Soak up the sun's rays as you lounge on the white-sand beaches or search for adventure with an airboat ride through the Mobile-Tensaw Delta (*cost not included*). A must during any stay in Orange Beach consists of an evening at The Wharf at Orange Beach. Dine on local seafood or casual Southern fare, browse the dozens of locally owned boutiques and one-of-a-kind shops, savor a nightcap, or ride the ferris wheel!

### DAY 4 WEDNESDAY, APRIL 30

### ORANGE BEACH

(Breakfast, Lunch, Dinner)

This morning, we take flight at **Flight Works Alabama**, an interactive aerospace exhibition featuring numerous exhibits, a cockpit simulator, and tours of the Airbus manufacturing facility to see how commercial aircraft are made. After a group lunch, we'll continue our journey to the **USS Alabama Battleship Memorial Park**. The park is dedicated to all Alabama citizens who have served in any branch of the United States Armed Forces. We'll tour the inside of the USS Alabama battleship, which served as the "Heroine of the Pacific" during World War II; step aboard the USS Drum submarine to learn about its crew and wartime missions; and admire the extensive collection of aircraft, historic vehicles, and war artifacts in the Medal of Honor Pavilion. After a delightful farewell dinner and an up-close look at the United States' military might, we will embark on a **sunset dolphin cruise** and enjoy the thrill of seeing wild dolphins at play in their natural environment! The remainder of the evening is yours to relax at our Orange Beach hotel.
