### DAY 1 FRIDAY, APRIL 17

### OVERNIGHT FLIGHT

Today, we will transfer to the airport for our overnight flight to **Amsterdam, Netherlands**.

### DAY 2 SATURDAY, APRIL 18

### AMSTERDAM, NETHERLANDS

(D)

We arrive this morning in the bustling city of Amsterdam in the Netherlands. After meeting our guide and motorcoach, we'll get acquainted with the city on a **panoramic sightseeing tour**. Known as one of the greatest small cities in the world, Amsterdam charms visitors with its calm and cozy atmosphere. The city is made up of a network of picturesque canals with small streets lining each side. The little squares, many bridges, and tall, thin houses lend a unique intimacy to the place, earning Amsterdam the nickname "Venice of the North." We will check in to our hotel for a three-night stay right in the heart of the city and then gather for a wonderful welcome dinner.

### DAY 3 SUNDAY, APRIL 19

### AMSTERDAM, NETHERLANDS

(B, D)

Today is a full day of sightseeing, beginning with the city's charming canals. We will board a boat for a **relaxing cruise along the canals** past the colorful gabled houses, arched drawbridges, and strikingly modern buildings of this young-at-heart city (*the cruise is dependent on the weather*). Next is the famous **Rijksmuseum**, which houses priceless paintings by Rembrandt and other Dutch artists. Moving on from traditional art to the art of brewing, we will learn about the history of beer and the brewing process at the **Heineken Experience** in the original factory. This afternoon, we'll head to a farm in the countryside south of Amsterdam. Here, we will **meet a cheesemaker** who will share his trade secrets with us and a clog maker who will transform wood blocks into footwear before our eyes! We will then return to the city and enjoy dinner in one of the many eateries just steps from the hotel.

### DAY 4 MONDAY, APRIL 20

### AMSTERDAM, NETHERLANDS

(B, D)

Following breakfast, we will head out of the city to marvel at field after field of brightly-colored tulips in bloom. It is truly a fantastic sight! Upon entering **Keukenhof**, the Netherlands' most famous garden, the beauty will envelop us, where over seven million bulbs from 800 varieties of tulips bloom in the spring. Plenty of time will be available to explore the acres of gardens and admire the kaleidoscope of flowers. We'll then continue to another important city, **The Hague**. Known as the "International City of Peace and Justice," it is the seat of the World Court. We continue to De Porceleyne Fles (The Porcelain Jar) to tour the Netherlands' most famous **Delft factory**. Founded in 1635, this is the only Delft factory remaining and is recognized as the standard against which all **Delftware** is judged. Following our tour, we will return to the city for dinner.

### DAY 5 TUESDAY, APRIL 21

### LUXEMBOURG CITY, LUXEMBOURG

(B, D)

We bid farewell to Amsterdam this morning as we head south to **Luxembourg City** with a fascinating stop at the **Bastogne War Museum**. Bastogne is a city that was integral in the Battle of the Bulge, fought toward the end of World War II. After months of fierce fighting, the American military pushed back German forces despite tremendous losses. The Battle of the Bulge ended on January 25, 1945, but came at an enormous cost. Described as one of the largest and bloodiest battles ever fought by the US, approximately 19,000 were killed and many more injured. **The Mardasson Memorial** is a tribute to those who died fighting for our freedom. After paying our respects, we will move on to Luxembourg City and check into our lovely accommodations for the next two nights. Dinner will be enjoyed as a group this evening.

#### DAY 6 WEDNESDAY, APRIL 22 LUXEMBOURG CITY, LUXEMBOURG (B)

Get to know lovely Luxembourg City as we embark on a **panoramic tour** this morning. The city is the capital of the Grand Duchy of Luxembourg, which lies at the crossroads of Germanic and Latin cultures. Luxembourg City is home to a superb UNESCO fortification, a fascinating pedestrian Old Town, Place Guillaume, and the Place d'Armes, to name just some of its notable sights. We'll visit the **grave of General Patton**, see the turreted **Grand Ducal Palace** (grounds only), and **tour Notre Dame Cathedral** (subject to availability). After lunch, we will visit the **Cistercian Orval Abbey**, famous for its history, brewery, and cheese factory. The rest of the day is yours explore and have dinner on your own.

#### DAY 7 THURSDAY, APRIL 23 BRUGES, BELGIUM (B, D)

We will drive through the Belgian countryside today to the riverside village of Dinant and **take a cable car to the citadel** perched high above the Meuse Valley. Step back in time as we explore the dungeons, kitchens, and weapons museum, uncovering the gripping history of trench warfare at Yser. Enjoy lunch on your own before we drive the short distance to the legendary site of the **Battle of Waterloo**, where we'll relive Napoleon's defeat by visiting the Memorial, Lion's Mound, and historic Hougomont Farm before moving on toward **Bruges**. As a special treat tonight, we will stop at a charming eighteenth-century bed and breakfast farmhouse where the owners will share the story of **Stamper Farm** and invite us to enjoy a delightful dinner!

#### DAY 8 FRIDAY, APRIL 24 BRUGES, BELGIUM (B)

After breakfast, we will head out to learn about the famous Belgian chocolate. At **Roose's Chocolate World**, we will learn how the chocolates are made before taking to the water on a **canal cruise** to appreciate the city's picturesque views from an entirely new perspective. Next is a visit to the **Lace Center** in the old lace school of the Sisters of the Immaculate Conception. Spend the rest of the day at leisure, soaking up the old-world charm of this beguiling city.

#### DAY 9 SATURDAY, APRIL 25 BRUSSELS, BELGIUM (B, D)

We'll head toward Brussels this morning with a stop midway through the UNESCO World Heritage-listed city of **Ghent**, considered one of Belgium's most beautiful cities. Here, we will **embark on a city overview tour** to see some of the city's most legendary landmarks, such as the sacred structure of **St. Bavo's Cathedral**, the **Castle of the Counts of Flanders**, **St. Nicholas' Church**, and the **ancient port of Graslei**. Following our tour, we'll continue on to the vibrant city of **Brussels**. After lunch at your leisure, we will enjoy a **panoramic tour of the highlights of Brussels** before checking in for a two-night stay in our city-center hotel. Get ready for a fun dinner experience!

#### DAY 10 SUNDAY, APRIL 26 BRUSSELS, BELGIUM (B, D)

Today, we will delve deeper into Brussels on another **sightseeing tour** before participating in a **chocolate-making workshop**. The remainder of the afternoon is yours to explore the city before our group gathers for a delicious farewell dinner.
