

#### DAY 2 SATURDAY, APRIL 18 AMSTERDAM, NETHERLANDS

We arrive this morning in the bustling city of Amsterdam in the Netherlands. After meeting our guide and motorcoach, we'll get acquainted with the city on a panoramic sightseeing tour. Known as one of the greatest small cities in the world, Amsterdam charms visitors with its calm and cozy atmosphere. The city is made up of a network of picturesque canals with small streets lining each side. The little squares, many bridges, and tall, thin houses lend a unique intimacy to the place, earning Amsterdam the nickname "Venice of the North." We will check in to our hotel for a three-night stay right in the heart of the city and then gather for a wonderful welcome dinner.

#### DAY 3 SUNDAY, APRIL 19 AMSTERDAM, NETHERLANDS (B, D)

Today is a full day of sightseeing, beginning with the city's charming canals. We will board a boat for a relaxing cruise along the canals past the colorful gabled houses, arched drawbridges, and strikingly modern buildings of this young-at-heart city (the cruise is dependent on the weather). Next is the famous **Rijksmuseum**, which houses priceless paintings by Rembrandt and other Dutch artists. Moving on from traditional art to the art of brewing, we will learn about the history of beer and the brewing process at the Heineken Experience in the original factory. This afternoon, we'll head to a farm in the countryside south of Amsterdam. Here, we will meet a cheesemaker who will share his trade secrets with us and a clog maker who will transform wood blocks into footwear before our eyes! We will then return to the city and enjoy dinner in one of the many eateries just steps from the hotel.

### DAY 4 MONDAY, APRIL 20

AMSTERDAM, NETHERLANDS

Following breakfast, we will head out of the city to marvel at field after field of brightlycolored tulips in bloom. It is truly a fantastic sight! Upon entering Keukenhof, the Netherlands' most famous garden, the beauty will envelop us, where over seven million bulbs from 800 varieties of tulips bloom in the spring. Plenty of time will be available to explore the acres of gardens and admire the kaleidoscope of flowers. We'll then continue to another important city, The Hague. Known as the "International City of Peace and Justice," it is the seat of the World Court. We continue to De Porceleyne Fles (The Porcelain Jar) to tour the Netherlands' most famous Delft factory. Founded in 1635, this is the only Delft factory remaining and is recognized as the standard against which all **Delftware** is judged. Following our tour, we will return to the city for dinner.

#### DAY 5 TUESDAY, APRIL 21

LUXEMBOURG CITY, LUXEMBOURG (B, D)

We bid farewell to Amsterdam this morning as we head south to Luxembourg City with a fascinating stop at the **Bastogne War Museum**. Bastogne is a city that was integral in the Battle of the Bulge, fought toward the end of World War II. After months of fierce fighting, the American military pushed back German forces despite tremendous losses. The Battle of the Bulge ended on January 25, 1945, but came at an enormous cost. Described as one of the largest and bloodiest battles ever fought by the US, approximately 19,000 were killed and many more injured. The Mardasson Memorial is a tribute to those who died fighting for our freedom. After paying our respects, we will move on to Luxembourg City and check into our lovely accommodations for the next two nights. Dinner will be enjoyed as a group this evening.

As a special treat tonight, we will stop at a charming eighteenth-century bed and breakfast farmhouse where the owners will share the story of Stamper Farm and invite us to enjoy a delightful dinner!
