DAY 1 MONDAY, AUGUST 24

PORTLAND, OR

(D)

Today, we will transfer to the airport for our flight to **Portland**, known as the “City of Roses.” Upon arrival, our tour manager will briefly introduce us to this bustling city (*if time allows*). PORTLAND, OR

Our journey this morning follows the scenic banks of the Columbia River to the rugged shores of the Pacific Ocean. Our first stop is in **Astoria**, a historic town where the river meets the sea. Here, explore **Fort Clatsop National Museum**, a meaningful site commemorating the Lewis and Clark expedition, which spent the winter of 1805–1806 here after completing their legendary trek across the American wilderness. From Astoria, we’ll travel south along the Pacific coastline to the charming resort town of **Cannon Beach**. With its stunning ocean views, unique shops, and inviting seafood restaurants, it’s the perfect place to relax and enjoy lunch on your own. The afternoon brings more spectacular coastal scenery as we go to the famous **Tillamook Creamery**, where we can sample some of the region’s best cheese and ice cream. We’ll return to Portland this evening and gather for a delicious dinner before settling in for the night.

DAY 3 WEDNESDAY, AUGUST 26

LA CONNER, WA

Today’s adventure takes an exciting turn as we cross the border into the beautiful province of British Columbia, Canada. But first, we begin with a visit to the newly renovated **Mount St. Helens Visitor Center**, where engaging exhibits and panoramic views offer insight into the powerful eruption that reshaped the region’s landscape.
